

WE LOVE BEAUTY POLICIES

- **PERMANENT MAKEUP AND/OR MICROBLADING RESULTS ARE NOT GUARANTEED** There are many factors that affect the healing process of the skin (i.e. what product you use on the tattooed area, healing process (Keloids), pigment retention, or allergies.) If you feel there may be an allergy issue let Carolina know at the time you make the appointment. She may require a free allergy patch test 24 hours before your consultation to determine if there is an allergy issue or not. There is absolutely **no guarantee** with healed results. An additional touch-up is required within 6-12 weeks to achieve optimal healed results. **On Microblading**, as we use a feathering technique only, the use of brow cosmetics products may still be required to achieve your desired look.
- **SAFETY AND MACHINERY:** we ask that you do not bring children or guests with you to your appointment, for some reason
- **UNDER NO CIRCUMSTANCES, WILL ANYONE UNDER THE AGE OF 18 BE ALLOWED TO HAVE PERMANENT MAKEUP OR MICROBLADING PERFORMED BY CAROLINA STEVENS, DBA, WE LOVE BEAUTY STUDIO. IT IS THE STATE LAW.**
- **DEPOSITS:** A card must be secured on file and a \$100 Deposit is required at the time of booking your consultation/appointment. The deposit is transferable if you have to re-schedule an appointment within 24 hours' notice. The deposit is deducted from your final bill upon receipt. *We require a consultation before any permanent makeup and/or microblading procedure, no exceptions.* The consultation is free (no charge), and an appointment will be scheduled for a later date after Carolina has assessed what your needs are.
- **CANCELLATION POLICY:** As these appointments take considerable time, we require **24-hour** notice to reschedule an appointment. This gives others an opportunity to take that time slot. If you cancel with less than 24-hour notice the **full deposit of \$100** will be automatically forfeited. Please contact us if you are not able to make your appointment or if you are running late. We understand life happens and we will do our best to accommodate you. Because of time restraints, being 20 minutes late may result in a forfeit of your deposit and re-scheduling of your appointment.
- **NOSHOWS:** The deposit will be forfeited if the client fails to show up for their appointment and an **additional \$50 fee** will be applied to reschedule. We respect your time, please respect ours.
- **FINAL NOTE:** *If you're happy with your results, tell your friends, we love rewarding our clients who send us referrals. We offer discounts for referrals on future services with Carolina. If you're not happy with the final results please feel free to contact Carolina, she will make sure the problem is corrected within the time limit and her professional ability.
