I understand I should continue taking my medications, and tell my technician about all prescription and non prescription drugs, supplements, topically applied products, eye drops, etc. that I use or take. I understand permanent makeup is a tattoo process; it is not an exact science, but an art. I have been informed of the general nature of permanent makeup and the specific nature of the procedure(s) described above.

Risk of procedure(s): I understand there are risks associated with permanent makeup, including, but not limited to: Infection: Procedures which involve penetrating the skin could cause infection; Scarring: Recovery from the procedure(s) could lead to scarring; Allergic reaction: Pigments, dyes, or other materials used could cause a reaction; Color: Colors will vary based on skin tone, pigments may fade over time; Irregularity: Pigments may fan or spread, causing makeup lines to blur; Corneal Abrasion: Rubbing or scratching eyes or applying contacts shortly after an eyeliner procedure could cause an abrasion; Permanence: Permanent makeup is intended to produce long-lasting changes to appearance which may be difficult or impossible to modify or remove.

Pigment Allergy Patch Test: While an allergy patch test is recommended, it does not always accurately predict whether you will have a reaction. If waived, you release the technician from liability if you do have an allergic reaction

Policies

- ❖ **Deposits:** An approved credit card must be secured on file. A deposit of \$100 is required at the time of booking your appointment, and will be applied to the cost of services rendered. The deposit is transferable if changes are made to the original appointment within 24 hours of booking. *We require a consultation prior to any services rendered.* The consultation is free, but we ask that you are courteous and respect the promptness of others. Lateness to appointments will result in a fee; 20 minutes late - \$20
- ❖ **Cancellation Policy:** We have a 24-hour cancellation prior to appointment policy, to provide others with the chance to reserve your time slot. **Cancellation outside of the 24 hour window** results in forfeiture of the \$100 deposit. Please contact us if you are not able to make your appointment. We understand life happens but must respect the time of others.
- ❖ **No Shows:** The deposit will be forfeited if the client fails to show up for the appointment, and an additional \$50 fee will be incurred to reschedule.
- ❖ **Touch ups:** Any touch up services rendered are not included in the original pricing. Touch ups are required to enhance the permanent makeup service due to client skin retention and pigmentation.
